Our education programs span the full spectrum of entry level education through high school and adult We offer programs that are tailored for classroom and field teaching with a strong ecology theme Ecology is presented through a science-based environmental format, and covers many of the more important California State Science Standards Our Wetlands Discovery Program is offered for 3rd through 5th grade students We reach over 2000 students in this program alone each year The format for the Wetlands Discovery Program is a classroom presentation followed by a field trip the same week Our other education programs are offered as field trip or presentation format, after school programs (grades 6 - 8), Summer programs (grades 2 - 6), and our RAILS program for teens, (Research, Advocacy, Identification, Leadership, and Stewardship) provides education for young adults in environmentally themed projects RAILS encourages young adults to explore careers in wildlife biology, field ecology, and environmental education Offering participants a chance to develop skills in environmental research, advocacy, identification, leadership and stewardship SCVAS also offers numerous opportunities for adults to learn about birds, nature and ecology In total, our education programs reach over 5000 individuals per year

4b (Code) (Expenses \$ 83,921 including grants of \$ 0) (Revenue \$ 182,159)

Our number one conservation project is protection of burrowing owls and their habitat in the Santa Clara Valley area We have several trained biologists that work with us to monitor and maintain various spots around the area for burrowing owl conservation One site that is our responsibility is in San Jose California at the Santa Clara/San Jose Municipal Water Treatment Plant SCVAS has managed the water treatment plant 200 acre burrowing owl land for the City of San Jose for the last four years The nesting burrowing owl population at this 200-acre site has increased for the fourth consecutive year This year, our burrowing owl biologists counted 12 pairs with a minimum of 58 young, up from 10 pairs with 46 young last year and eight pairs with 17 young in 2014, and six pairs with 12 young in 2013 It is paramount that SCVAS continue conservation efforts throughout the Santa Clara Valley as development pressures and habitat loss continue to increase, and the burrowing owl population decreases throughout its range

4c (Code) (Expenses \$ 79,057 including grants of \$ 0) (Revenue \$ 70,303)

SCVAS is instrumental in working with our city neighbors to identify and recommend bird-safe design development projects We have been successful with 5 major city municipalities in getting their city council members to adopt and recommend our bird-safe design guidelines for urban development This is essential for keeping a stable number of bird species from "strike kills" in an ever growing urban area This is hard work and our advocacy is representative of our ability to win appreciation for the importance of bird habitat in our neighboring cities SCVAS also works with large commercial entities to do the same awareness with their employees on various campuses, such as Google who has an environmental design team that we work with, and Facebook who established an 8.3 acre roof-top native plant habitat on one of their newer development sites based on our collaboration SCVAS also works with our members and stakeholders to emphasize bird habitat designs for neighborhoods and private housing These wins are essential in protecting urban bird habitat and species
