### **Form 990, Part III, Line 4a:**

Conservation - Our main conservation program is managing a 200 acre site in San Jose with an established residence of breeding pairs of Burrowing owls. We were just awarded a 5-year contract to continue our work and create reports that are given to the city of San Jose, the Santa Clara Valley Habitat Agency, US Fish & Wildlife, California Fish & Wildlife agencies. We had over 30 mating pairs of Owls this year with more than 50 chicks. This area continues to have a small growth of Burrowing owl activity, where other sites within Santa Clara County managed by other groups have declining numbers. We work collaboratively with all the groups and participate in ongoing plans to save the owl from being completely eliminated from Santa Clara County. Development and residential growth are the main factors for loss of Burrowing owl habitat. We work with everyone in the county to bring awareness to the possibility of extinction of the Burrowing owls in our area. Other conservation programs include neighborhood awareness for bird friendly landscapes, bird friendly design of buildings and houses, along with the conservation efforts we conduct in support the National Audubon yearly goals which impact bird habitats and preservation.

---

**Form 990, Part III, Line 4b:**

Education - Our Wetlands Discovery Program has been inspiring young minds to become more involved in conservation since 1988. We aim to show students, grades 3-5, the value of wetlands and how they support the birds and other wildlife that inhabit them. By giving students this real-life experience, we hope to encourage them to consider the impact they are having on the earth, and to determine ways that they can make a difference. Since 1988, we have served more than 10,000 students with the Wetlands Discovery Program. The entire program is regularly updated with the California Science Standards. We are now working on next year's Next Generation Science Standards that will expand our science delivery with this program to be more compliant with our Nation's science plans and goals. There are two main components to the Wetlands Discovery Program: the in-class section and the field trip.

**In-Class** During the in-class section, docents visit the school to teach students about basic environmental concepts relating to birds and the wetlands using visual aids to assist in the completion of a worksheet. Students are also trained to use binoculars so that they are prepared for the field trip!

**Field Trip** For the field trip portion, students are led around a local bayland by knowledgeable docents. Students get to use binoculars and exercise the knowledge they gained in class. Afterwards they often ask where they can get their own binoculars and where to use them! Teachers have told us about students who report that they have taken their families back to the baylands to show them the birds and what they've learned. Other education programs are targeted towards adults and families including beginning birding, building nest boxes for birds, and designing a bird friendly yard. These programs provide an inroad to the community they help us grow our memberships which in turn helps us continue to increase the awareness for bird preservation.

---

- Save Panoche Valley Supports well-placed alternative energy and opposes a landscape-scale solar array which would destroy this designated Important Bird Area of Global Priority
