Regular Meeting; Monday, Oct. 11, in the Junior Museum at Community Center in Palo Alto at 8 p.m. The program will be an illustrated lecture by Mr. John P. Figg-Hoblyn of the Stanford University Natural Museum, entitled "Here and There in Baja California." Visitors are welcome.

FIELD TRIPS:

Sunday, Oct. 10, 1954, to Mt. Madonna Park with Margaret Hudson as leader. Meet the group at 5th and San Carlos Sts., in San Jose at 8 a.m. or join the group at 9:15 a.m. at the entrance to Mt. SEPTEMBER REVIEW

The regular meeting of the Society on Sept. 13, held in San Jose produced a record turnout, and was an auspicious beginning to the new season. The programs at these regular meetings represent thought and considerable effort on the part of the society's Vice-President and program chairman, Dr. Mal Miller. Evidently the

members are beginning to realize that they are too good to miss.

At a special Board of Directors meeting held that same date official action was taken on several matters of importance.

Dr. Richard Mewaldt was appointed to the Board filling a recently created vacancy. The proposal that the Santa Clara Audubon Society join with Sequoia Audubon and National Audubon in a sanctuary project involving salt marsh land in San Mateo County and Alameda County was rejected. It was decided that field trips shall be limited to three per month. It was decided that two of the regular monthly meetings of the society shall be held at Los Gatos between November and May, 1955.

A resolution that the Audubon Society of Santa Clara County shall incorporate for reasons of protection of its members, was passed and this proposition is scheduled for presentation at the October meeting.

It is necessary that the proposed amendments and additions to the By-Laws be voted on by the members at the next regular meeting of the society. The propositions are as follows:

PART 1 - VOTE ON PROPOSED AMENDMENTS TO THE BY-LAWS

Approved at the June meeting of the Board of Directors and read at the Annual Meeting of the Society, the following proposed amendments to the By-Laws will be acted upon by the members present and voting at the October regular meeting of the Society:

Proposition A - Amend Article VIII, Section 11, by inserting the words THE AVOCET in the blanks in the sentences reading as follows: "It shall by the duty of the Editorial Committee to plan, organize, and arrange, for prompt, economical issuance, under high editorial standards, of the information publication of the Society issued under the name of ______, and for its effective distribution. The Editorial Committee shall prepare rules and practices covering the distribution of ______ to libraries and institutions, or individuals, not participating members of the Society; and rules covering the preservation of reference and office copies, and of binding; all such rules shall be approved by the Board of Directors and shall be maintained on file by the Committee available for reference, and for the guidance of successors and members generally."

Explanation of Proposition A - When the By-Laws were revised, the name of the publication had not been determined. Blanks were left in Section 11 of Article VIII for the future insertion of the name of the publication. The recent contest to select a name for the bulletin provided the title. The Publication Standing Rules have already been amended, and the September issue of THE AVOCET has placed the new title into use. Amending the By-Laws will complete the necessary parliamentary action.

Proposition B - Amend Article V, Section 1, by adding the following sentence: "In the event a meeting of special interest to this Society shall be scheduled in the area served by this Society during the week preceding, the week of, or the week succeeding a regular meeting of the members of this Society, the President, upon the recommendation of the chairman of the Program Committee, with the approval of the Board of Directors, may substitute the special-interest meeting for the regular meeting, provided that the members of this Society shall be notified by mail or in the publication of the Society in sufficient time."

Explanation of Proposition B - During the 1953-1954 term of Vice-President Dr. Malcolm Miller, who was also chairman of the Program Committee, Dr. Miller suggested that something be done to relieve the calendar congestion brought about by

the scheduling of a regular meeting, a Board of Directors' meeting, an Audubon Screen Tour, and field trips within a week's time. The Board of Directors referred his request to the By-Laws Committee for recommendation. The proposed amendment was developed to ease the scheduling problem of the Program Committee.

PART 2 - SHALL THE SOCIETY INCORPORATE?

The question of incorporation for the Santa Clara Valley Audubon Society is not a new proposal. Many times in past years individual members and/or groups of members have advocated the action.

The subject was brought into focus again because of an opportunity to join a sanctuary project with the Sequoia Audubon Society and the National Audubon Society. The project would involve the signing of contracts (use permits) with the industrial firms owning the proposed sanctuary lands, and would require the carrying of public liability insurance by the three Audubon groups.

The Sequoia Audubon Society has already taken legal steps toward incorporation.

The Board of Directors sought the legal opinion of Mr. Henry Hill with reference to the advisability of incorporation and the legal acceptability of the several contracts under consideration. Mr. Hill strongly recommended incorporation, and personally offered to prepare the necessary legal documents and to pay the necessary fees if the Society determined to proceed with the action.

Although the Board of Directors rejected the proposed sanctuary project at the special meeting, September 13th, it passed a resolution recommending that the members of the Society decide favorably upon incorporation at the October regular meeting.

Principal arguments in favor of incorporation include the following: (1) Incorporation would relieve any member, present or future, of financial liability beyond the resources of the Society. (2) Incorporation would assure continuation of the Society from year to year, (3) Incorporation would be necessary if the Society expects to own property or be eligible for gifts or bequests.

Principal arguments in opposition to incorporation include the following: (1) Incorporation is unnecessary; the members' financial liability beyond the resources of the Society is exaggerated. The present policy of placing the responsibility of insurance protection upon the driver of a field trip car is working satisfactorily. (2) The Society has been in existence for many years and shows no signs of going out of existence. (3) Incorporation would increase the cost per member per year; dues would probably have to be increased, or some kind of money-raising scheme undertaken.

Come to the October regular meeting if you want to express your opinion with reference to incorporation!

On the nights of October 1, 2, 3, 4, and 5 there will be observation posts in operation at Los Gatos, San Jose State College, the Palo Alto Yacht Harbor, and the East Foothills of San Jose. OCTOBER MEETING

The regular October meeting of the Santa Clara Valley Audubon Society will be held on Monday, October 13, 1952 at 8:00 p.m. in Room 210, Science Fldg., San Jose State College. The program will consist of several motion pictures on birds which will last about one hour. The films were recently acquired by San Jose State and will show many species of western birds in their native surroundings.

The return of wintering "crowned" sparrows, Fox Sparrows, and other seed-eaters will cause many Audubon Society members to lay in a supply of feed for their dooryard flock. Suet for chickadees, sunflower seeds for titmice, and seeds for the ground foraging sparrows.

The cheapest wild bird seed we know of is "water-grass" seed which may be obtained from Jay's Pet and Garden Shop, 668 Lincoln St., San Jose. The seed is \$5.75 per 100 lbs. with a 10% discount to Audubon Society members.
