### FIELD TRIPS

Sunday, July 14, to Fremont Peak State Park in San Benito County. Meet at 9:00 a.m. in the town of San Juan Bautista, at the entrance to the old mission of the same name. The Mission is now a State Historical Monument and part of the State Park System. Fremont Peak is 11 miles south from San Juan Bautista. Bring lunch. Wednesday Morning, July 24, to Portola State Park, among redwoods near headwaters of Pescadero Creek in San Mateo County. Meet at 8:30 a.m. on Skyline Blvd. at junction with Alpine Road (about 6 m. south from Saratoga Gap and 7 north from La Honda Road crossing). Bring lunch if you want more than a morning's trip. Saturday, August 10, to the Sharon Estate (the Sharons of Comstoke Lode fame) in the country back of Menlo Park. Meet at 8:30 a.m. in Menlo Park at corner of Alameda de las Pulgas and Avy Ave. Bring lunch if you want to spend the day on this interesting estate of the late 19th century, or in nearby areas. Wednesday Morning. August 21, to salt marshes and salt ponds near Alviso, at the south end of San Francisco Bay. New areas, away from all the "progress" that is going on in vicinity of Alviso, will be explored. There should be shore birds returning from nesting grounds far north, as well as resident birds of the marshy places. Meet at 9:00 a.m. at Alviso Elementary School on San Jose-Alviso Road. ### BRIEF REPORT OF ANNUAL MEETING

The Annual Meeting, which was held on June 10, 1957, in the Junior Museum in Alum Rock Park, followed the customary late afternoon bird walk and picnic supper. (Of especial interest on the walk were the birds feeding at the orange flowers of Grevillea trees: a family of Bullock's Orioles, two Nuttall's Woodpeckers, one Acorn Woodpecker, and a Black-headed Grosbeak, along with an Allen's Hummingbird. Were they all sipping nector? E.S.) Reports read at the meeting by the chairmen showed accomplishment. Membership, according to Angelina Snow, has reached 250. Henry Weston reported meetings held regularly in both Palo Alto and San Jose. William Ouderkirk reported completion of two projects: one in which we joined other local Audubon Societies, The National Audubon Society, and the Sierra Club to establish the South San Francisco Bay Marsh Sanctuary; the other, the posting of the grounds of Villa Montalvo as a Wildlife Sanctuary. He also told of communications sent to assemblymen and senators urging passage of the bill to revise the California Fish and Game Code, relating particularly to protection of hawks and owls. Francis Goraj reported 32 field trips, with attendance varying from 5 to 75. Jand Goraj told of increased effectiveness of the Publicity Committee and wider participation in its work by members. Emily Smith reported that Joyce Todd will

take over the editorship of <u>The Avocet</u>, beginning with the September-October issue. Fanny Zwaal's Treasurer's Report showed our financial status to be good, and Dr. Marion Kirkwood, as the auditor, attested to the accuracy of the report. Dr. Arnold Applegarth reported a financially successful Screen Tour season. This has made it possible for us to grant seven scholarships to West Coast Nature School and two half scholarships to the Audubon Camp of California. The awarding of these scholarships is a concrete way to further our belief in the value and need of conservation education. Harriet Mundy, Chairman of the Nominating Committee, submitted the names of the following for officers and directors for 1957-1958: President, Dorothy Wool; Vice-president, Henry Weston; Secretary, Roberta Wright; Treasurer, Fanny Zwaal; Directors, Anne Peterson, L. Richard Mewaldt, Charlotte McBride, Francis Goraj, and Robert Wood. After the slate was unanimously accepted President Dorothy Wool thanked the past officers and directors for their work of the past year and introduced the members of the incoming Board of Directors.

Following the business meeting, Mr. Larry Moitozo, Director of the Junior Museum, presented a very interesting program about the "long field trips" which the Museum is now offering boys and girls, illustrating his talk with Kodachrome slides of a recent camping field trip to a desert area. He then introduced Jean Erdelyi who was one of the dozen or so boys and girls on the trip. She told, in her own delightful way, about the things they saw and learned and the fun they had. The program was one we shall long remember as a fine example of conservation education in action.
