

FIELD TRIPS:

Unsurprisingly, due to to the COVID-19 pandemic, our field trip schedule has been suspended until further notice. The Bay: Don Edwards Environmental Education Center



ENVIRONMENTAL NEWS:

As SCVAS works to promote and protect birds and their habitat in Santa Clara Valley and beyond, we occasionally pause to look at our successes. We are proud of our work in Mountain View to protect the Egret and Heron rookery on Shorebird Way, and advocate for restrictions for boating near the Black Skimmer island. We are also happy with the recent removal of spikes to allow Cliff Swallows to return to the Coast Casey pump house. In Palo Alto, we were able to save some of the reeds of the Emily Renzel Marsh. The reeds now provide shelter and nesting sites for green herons, common gallinules, marsh wrens and common yellowthroat. Our work for the protection of Coyote Valley is progressing, and Bird Safe Design is becoming widespread in our cities.

But our work is never done. We have recently commented on Mid Peninsula Open Space District wildfire plans and asked Midpen to be less aggressive in their planned removal of all Eucalyptus trees, and to protect nesting areas of Red-shouldered Hawks and neotropical migrants such as the Olive-sided Flycatcher. And in San Jose we are opposed to the expansion of light pollution in the form of electronic billboards and on Highways 237 and 87.
